Dear CEOS and GEO colleagues,

We are delighted to invite you to our first face-to-face CEOS SDG AHT meeting in Washington DC, hosted at the Embassy of Australia, on Wednesday 8th and Thursday 9th of March 2017.

The main objectives of this workshop are:

- Discuss and identify the **main activities/strategic directions** to be undertaken by the team
- Enhance our **collaboration with GEO** on the SDG topic
- Produce a **final draft Terms of Reference** document– ready for submission to CEOS Secretariat before the endorsement at a Plenary
- Develop a Work Plan to be presented for discussion at CEOS SIT-32 in April
- **Inform external partners** on CEOS work (from the Washington area including international organisations and banks) and **initiate potential partnerships**

The first day is fully dedicated to CEOS work, including how to reinforce our collaboration with GEO on this topic – the main ojective is to produce a FINAL draft of the Terms of Reference, and a draft Work Plan.

The second day is dedicated to networking information sharing with external organisations and potential partners – the CEOS SDG Ad Hoc Team will inform them about CEOS and GEO, and the activities on the SDGs, and some invitees will present their organisations' views and/or projects related to SDGs. At the end of the day, the objective is to discuss and identify potential collaborations around Earth observations in support achieving the UN 2030 Agenda.


