Updates on issues raised during the <u>last</u> CEOS SEC teleconference (<u>Dot points</u>)

- Freshwater from Space. The workshop has been ongoing since Tuesday morning. Approx 40 people mainly from US and Europe, several representatives from Asia also. Substantial place for Break-out discussions in the format which is challengeing from an organisational point of view, but rewarding in terms of the discussions that are generated. Overall the outlook is looking positive. Arnold aims to provide a web news story by the beginning of the week.
- CEO continuity. No progress has been made. I will plan a TC of the search team in November.
- Interest from Hungarian Space Office in CEOS Associate status. Following exchanges with the HSO regarding potential associate status, it has become apparent that it is not clear whether it is possible to decide on new CEOS associates at a Plenary session during SIT. Most feedback has suggested that this is not an appropriate time to decide on any CEOS membership issues (including new CEOS associates). If CEOS-SEC agrees with this, it is proposed that we bear this in mind for a minor update of the CEOS TORs to codify this whenever it is possible to do so.
- CEOS Work Plan 2019-2021 development begun. As scheduled, the development cycle for the 2019-2021 CEOS Work Plan has begun. Following advice from CEOS Plenary, the first deadline for inputs is within 10 days.

 Report on GEO XV. Successful plenary meeting which was attended by a small CEOS delegation, but many CEOS friends were included in other delegations. GEO Associate category to be established, this category will allow commercial companies to participate in GEO activities and contribute financially to GEO Trust Fund. Some GEO members expressed some reserves and a set of issues remain to be ironed out, however this new category will go ahead following a report from a small group due ono March 2019. Result orientated GEOSS was supported by GEO members and EXCOM, but some reserves remain on the implementation, specifically with regards to in situ measurements which GEOSEC director anticipates could be managed/curated etc centrally by a GEOSEC run capacity. Side meeting among CEOS representatives to discuss support to SDG implementation within CEOS. Some proposals have been made and will hopefully progress in the coming months.

- WGISS representation and report during the 32nd CEOS Plenary.
- WGISS-46 meeting hosted by DLR in Oberpfaffenhofen (Munich, Germany) on 22-25 October with about 30-35 participants (several from DLR). Joint session on WGISS-GEOSS Future Data Architectures (FDA) and interoperability aspects.
- WGISS presentation during GEOSS-EVOLVE side event at the GEO-XV Plenary held in Kyoto at end October 2018.
- New WGISS brochures approved used during WGISS-46 and distributed at the CEOS booth at the GEO-XV Plenary. Brochures will be as outreach material in all upcoming events with WGISS participation.
- WGISS will prepare input for the CEOS 2019-21 Work Plan to address the mandate on Future Data Architectures (FDA) and other WGISS related activities. Terms of Reference will be updated to highlight WGISS mandate in the frame of Future Data Architectures.

Close follow-up of the activity in coordination with COVERAGE team.
 - WGCV on four identified topics. Next joint teleconference scheduled in December.
 - Carbon Team on prototype carbon portal development. Carbon Portal development team looking into the possibility to support a case study on forest monitoring in the Mekong area. Next call will be held in December.
 - WGClimate on ECV inventory Version 2.0 datasets registration in IDN as first step for accessibility through WWGISS Connected Data Assets Infrastructure. Registration progressing in coordination with WGClimate chair using the FedEO dedicated "fast registration" procedure also used in the frame of the COVERAGE/WGISS activity.
 - **WGCapD** for technology and user oriented webinars. WGISS support for FDA demonstration during SAR training/meeting in Vietnam being discussed with WGCapD.
 - **WGDisasters:** generic recovery observatory highlighted as possible cooperation area during WGDisasters meeting#10, to be further discussed.
 - Virtual Constellations to update the inventory of Virtual Constellations datasets and ensure discoverability/accessibility through WGISS Connected Data Assets infrastructure. Inventory update to be started.
 - **GEO:** potential WGISS additional contribution to GEO/GEOSS in the frame of FDA and technologies will be defined based on the outcomes of the WGISS-46 joint workshop.
 - WMO (World Meteorological Organization): collaboration with the WMO International Expert Group on Climate Data Modernisation (IEG-CDM) will be discussed including possibility to organize a joint session at WGISS-47.

- Data Preservation and Stewardship
 - White Paper on "Data Stewardship Reference Model and Measuring Earth Observation Data Usage Best Practice" being finalised with additional input received during WGISS-46 meeting.
 - Proposal for GEO Data Management Principles Implementation Guidelines (DMP IG) improvement/update on the basis of CEOS WGISS Maturity Matrix being drafted.
- Data Discovery and Access (WGISS Connected Data Assets Activities)
 - A simplified procedure to allow collections/granules discovery and access through FedEO and automatic registration in IDN is being used to increase number of partners and collections and in different cooperation activities.
 - All FedEO data collections are being registered in the IDN; granule access to FedEO datasets registered in the IDN will be provided through FedEO.
 - Activities started with JAXA for discovery/access through WGISS CDA and automatic registration in IDN.
 - Activities progressing with DMR and EUMETSAT.
 - Activities to be resumed with ROSCOSMOS.
 - ESA is contacting data providers for Essential Climate Variables (ECV) and COVERAGE (CEOS Ocean Variables Enabling Research and Applications for GEO) collections registration.
 - National Remote Sensing Center of China (NRSCC) has confirmed possibility of metadata harvesting between WGISS Connected Data Assets (CDA) and ChinaGEOSS platform on a periodical basis. Tests with CWIC are starting.
 - GEOSS Platform team will add CEOS IDN in the catalogues visible and accessible through the GEOSS Platform. This will increase visibility of CEOS contribution to GEO/GEOSS.
 - WGISS Connected Data Assets Client Partner document to describe process to access WGISS CDA from client portals being finalised by System Level Team (SLT).
- Interoperability and Use
 - Future Data Architectures:
 - FDA actions assigned to WGISS in the CEOS 2018-2020 Work-plan are being actively discussed and addressed by WGISS members with substantial progress.
 - Open source Software and tools inventory lists now more than 90 items; DB implementation solution is under analysis in coordination with SEO. Updated DB requirements collected during the WGISS#46 meeting.
 - First version of FDA inventory table produced and distributed for review.
 - o New version of the WGISS Carbon Portal was issued and presented during WGISS-46.
 - Research Data Alliance (RDA) working groups may have relevance to the work of WGISS. Additional investigations might be done.
- Technology Exploration:
 - Next webinar will focus on "Tools and Data Interoperability Demonstrations" and will be organised in cooperation with WGCapD. It might consist in a dedicated session or workshop during WGISS-47 meeting.

- The ACIX2 (Atmospheric Correction Inter-Comparison eXercise) Cloud Mask Inter-comparison Exercise (CMIX) held its first meeting in October 2018. Some early results are
 - There has been a three- fold increase in participation in this exercise (35 teams in total from US, Europe, Australia), testimony of the success of the first exercise and the value of this exercise to the community;
 - This exercise will draw upon the RadCalNet (another WGCV initiative), other international endeavours such FRM4VEG, AERONET and agency data such DLR, GA and others;
 - 3 protocols (Cloud Screening, AC over land, AC over water) were discussed during the meeting, and, the exercise will consider ESA's DIAS, Synergise's AWS, and, Coastal Thematic Exploitation Platform (C-TEP) to mitigate the anticipated issue with the download and processing of the large volumes of data involved in the comparison;

- A joint meeting between WGClimate, ACVC and WGCV was held on 5 November 2018 (via teleconference and in person) to discuss collaboration on the CEOS GHG activities. WGCV is now working with WGClimate and ACVC to define WGCV's potentially contribution which may draw upon several of WGCV's sub-groups;
- Good progress has been made on the joint WGCV pre-flight optical calibration workshop. A flyer has been drafted and organising committee members are now being selected.

- Agency representatives are performing trial assessments against the CARD4L PFS. Their feedback and experience will be used to refine the PFS for their first scheduled update and to define the process for data providers to assess their products as CARD4L. LSI-VC will maintain the necessary link to WGCV for peer review of assessments.
- The new collection of SAR CARD4L PFS are progressing. These are expected to be ready for and endorsed at LSI-VC-7.
- LSI-VC members are working to ensure coordination between LSI-VC and the activities of the participants of this <u>workshop</u> to avoid divergence in SAR ARD specifications and approaches.
- LSI-VC has been approached by members of the GEO LDN community. They are
 interested in the concept of ARD for LDN processing data flows, as well as the process
 behind developing the PFS. There is also a possible connection to be made between the
 LDN community and LSI-VC regarding their observing requirements and the reboot of
 our requirements work. GEO LDN representatives may be invited to LSI-VC-7.
- The <u>CEOS ARD website</u> has been updated with additional information, in particular with resources for data producers, distributors, and users.

Issues requiring discussion/decision during <u>current</u> CEOS SEC teleconference

SDCG EXEC has noted the schedule for the new CEOS WP and started discussions with WGCV/LPV around new joint targets related to Biomass measurement missions and activities promoting their uptake and relevance across GFOI countries. This is a new kind of collaboration across the CEOS structure and will take some time. The subject is complex also. We are flagging to the CEO that we may sketch some broad targets for inclusion as markers in the new WP version – with plans to flesh them out in due course.

Other highlights, activities, actions, projects, collaborations

- USGS SilvaCarbon has identified funding to be able to support the placement of a USGS rep back in SDCG. Tom Maiersperger has been nominated and confirmed that he is willing to serve as a Co-lead alongside ESA and UKSA – which is essentially a means for sharing the load around SDCG WP tasks, telcons and meetings. SDCG enthusiastically welcomed Tom to his first telcon last month and look forward to working with him.
- FAO and World Bank have both stepped up to be identified as Co-Leads for the GFOI Data Component. What this means in practice is TBD. FAO is keen to promote their SEPAL tool for countries. World Bank is starting a new Forest Remote Sensing programme. Data issues are assuming increasing prominence within GFOI generally.
- World Bank responded extremely positively to an invitation to help formulate the SDCG Biomass activities, including helping to 'accelerate the policy relevance of the new generation of biomass missions' (our headline objective).

 SDCG-15 dates confirmed and will be hosted by NASA SEO in Virginia on 27 and 28 March. The day prior will include WGCV LPV folks (from Goddard) and be dedicated to formulation on biomass cooperation. World Bank also been made aware of the event.
