2nd Expert Advisory Group (EAG) Meeting, 5-6 February 2019, Geneva,
 Switzerland

The Secretariat presented the draft Infrastructure for Results-oriented GEOSS document to the 2nd EAG meeting for discussion. The document reprised the vision for a results-oriented GEOSS and defined the concept of a GEO Knowledge Hub (comprising research papers on methods and results; software algorithms used for processing; in situ and satellite imagery data used; and results), before considering issues related to implementation of the Hub such as the use of cloud computing services; in situ data sources (including household surveys, in field campaigns, and citizen science) as well as barriers related to sharing; multisatellite data analysis and processing; technologies required to build the Hub; and integration of the GEOSS Platform with the GEO Knowledge Hub.

The EAG requested clarification pertaining to aspects of the proposal, such as: how the Hub can be leveraged to help activities of the GEO Work Programme upscale globally; how to ensure that end-users would find information on the Hub to be relevant, as well as be capable of understanding and using it; what is meant by "data curation", who will perform it, and if it is to be the Secretariat, are there sufficient resources; what are the implications for privacy and intellectual property rights when using publicly available cloud computing services, as well as the sustainability of a Hub that relies on these services (especially if provided by the commercial sector); to what extent should the in situ data stored by the Hub be related to activities of the GEO Work Programme; what is foreseen in terms of capacity development; and how to best integrate the EO search and discovery capabilities of the GEOSS Platform with the Hub. These questions notwithstanding, the EAG gave its support for the Secretariat to go ahead and develop a small number of pilot cases for examination at the 3rd and final meeting of the EAG in April 2019. In the meantime, the Secretariat will revise the

Infrastructure for Results-oriented GEOSS paper to respond to the concerns of the EAG.
