 - Expect to prepare a Responsibilities and User Guide for the online Deliverables Tracking Tool
- GEO Working Groups Action
 - Sent email to CEOS community on 27 March with suspense of 15 April in response to request from GEO Secretariat for GEO Members and PO to nominate individuals to participate in the four GEO Working Groups that were created under the GEO Engagement Priorities Coordination and GEOSS Data, Information and Knowledge Resources Foundational Tasks of the 2020-2022 GEO Work Programme. The four Working Groups are: Capacity Development Working Group (CD-WG), Climate Change Working Group (CC-WG), Disaster Risk Reduction Working Group (DRR-WG), and the Data Working Group (Data-WG).

Please provide the name and email address, along with the name of the Working Group for which the person would like to participate to the CEO (kerry.sawyer@noaa.gov) and SIT Chair Team Representative (jonathon.ross@ga.gov.au) by 15 April 2020. CEOS Chair will prepare one nomination message for all Working Groups.
 - ACTION 2. Ask that any CEOS Agencies that will be nominating representatives to participate in the WGs on behalf of their parent agency or member country to please inform CEOS leadership.
 - Additional information: expect 3-5% time for anyone involved in the WG with approximately six phone calls of no more than 2 hours each; no required additional travel;
 - o Per decision from ExCom, POs will be limited to two participants per WG!

- The SIT Chair Team conducted a post-meeting survey on SIT-35. Some key findings out of the 26 responses were:
 - Respondents agreed that the virtual format for the meeting worked well. The
 use of Sli.do was particularly well received. The SIT Chair Team will use it for
 future meetings.
 - Participants typically felt that the content was suitable for a Principal-level SIT meeting. It was recognised that the agenda was perhaps too densely populated, limiting discussion time. Consideration could be given to additional days in future to alleviate the time constraints, but the ability of

- Principals to participate for additional days or longer sessions would need to be carefully considered.
- Regarding the topics, a couple of comments indicated that more time could be allocated for the CEOS working teams to present.
- It was noted, consistent with feedback from almost all previous CEOS
 meetings, that it would be good for presentations to have a clear series of
 suggested actions or proposals, or specific calls for advice from participants.
 The additional importance of this being available 'in advance' of a virtual only
 meeting was highlighted.
- Respondents suggested accommodating virtual participation at this level (e.g., Slido commenting) at future physical meetings.

 According to SIT-35 minutes decisions/actions that have been distributed to SEC (to be shared with the broader community after SEC):

SIT-35-01: CEOS Agencies are **invited to consider nominations for representatives and co-leads for the SDG** *Ad Hoc Team* **subgroups** (with Water, Urban and Land degradation focus) and to share agency activities of relevance to the AHT efforts on specific indicators.

The SDG AHT co-leads have been reaching out to some agencies, but hopefully nominations will be confirmed soon.

Other highlights, activities, actions, projects, collaborations

- Updated information shared with the AHT members with requests on nominations for the subgroups + preferences on SDG AHT evolution scenarios. Future of SDG AHT will be discussed at SIT Technical Workshop and presented to Principals
- Subgroups to be formally setup and kick-off work on 6.6.1 (water), 11.3.1 (urban) and 15.3.1 (land degradation) to deliver reliable, up-to-date and easily accessible information for the GEO SDG Toolkits. Next AHT Call on 21st April will be essentially dedicated to the set up and terms of reference of the 3 subgroups.
- The CEOS COAST Study Team in close cooperation with GEO Blue Planet will cover SDG indicator 14.1.1 (coastal eutrophication and plastic debris), but close coordination with SDG-AHT is required to follow an harmonised workflows across SDGs.
- Work with GEO EO4SDG on the SDG Toolkits initiated. SDG-AHT members (NASA, SANSA and ESA) participated in the first meeting of the GEO EO4SDG expert group that will develop the SDG 11 Toolkit in cooperation with UN Habitat.
- Work with the GEO specialised initiatives on the satellite data requirements initiated, including the list of CEOS Core missions matching with SDG indicators data needs, and refining the "Requirements templates" for GEO and the AHT subgroups (on water, urbanisation and land degradation). Discussions have started with the GEO LDN Data Quality Standards (QDS) Working Group on the Satellite Data Requirements for SDG 15.3.1 (Land Degradation).
- As mentioned at SIT-35, a draft <u>Data Supply Analysis and Strategy</u> is being reviewed by the AHT members (comments and feedback to be received by 20th April) - version 1 to be ready by June.

- More collaboration planned with GPSDD and WGCapD to get training more visible amongst the SDG community.
- Discussion with WGISS on EO enabling infrastructures is on-going.
- RSE Special Issue on SDG (high level paper) at its final editing stage
