- SIT TW 2023 dates have been very problematic in avoiding conflicts with existing schedules. An email was sent to the community proposing Oct 17-19. So far no objections. The Thailand Plenary will be late November 2023 so this still allows time to address issues between the two meetings.

Other highlights, activities, actions, projects, collaborations

Following the "New Space" session at the SIT TW and the decision to assemble a Task Team to further develop the 'New Space & Future CEOS' topics and initiatives, the New Space Task Team Terms of Reference (ToRs) are being drafted. A first draft version should be distributed to CEOS SEC members next week. The ToRs will be shared with CEOS ahead of the Plenary, and presented to the CEOS Principals participating in the Plenary, for endorsement.

Carbon & Biomass

- SIT Chair Team is cooperating with the AFOLU Roadmap Team leads and Lead Author, Ben Poulter (NASA), to forge the way forward on the Roadmap following the ESRIN workshop. A team call is scheduled for 6 December. It is likely that the GHG and AFOLU roadmaps will in due course need to demonstrate together consistently how CEOS overall will respond to the challenges of the Paris Agreement and the GST, incorporating bottom-up and top-down approaches to an eventual Monitoring and Verification System.
- The CEOS GST Portal has been updated ahead of the UNFCCC COP-27 meeting in Egypt. A number of dataset profiles have been updated. A new website section on 'User Stories and Inspiration' has been added with articles being contributed by GEOGLAM and SilvaCarbon. thanks to the dataset coordinators and to lan Jarvis and Sylvia Wilson. All content is available in English, French and Spanish at ceos.org/gst.

CEOS-ARD

- The CEOS-ARD Oversight Group, LSI-VC, and representatives from WGCV and WGISS provided input on the draft OGC ARD SWG Charter and ISO NWIP. Funding and organisational delays on the OGC side means that the process will be delayed. We welcome the opportunity to take a bit more time and have further discussions between the CEOS and OGC teams to develop a strong foundation for any ARD standards that might follow.
- LSI-VC and the CEOS-ARD Oversight Group are working with interested parties (e.g., WGISS, WGCV) to formulate an action for CEOS Plenary to further define and develop the concept of a CEOS Interoperability Framework.
- CEOS-ARD has been represented at Pecora 2022, GEO Week (via the CEOS booth), and this week at the Very High-resolution Radar & Optical Data Assessment (VH-RODA) 2022 Workshop which is being held in ESA-ESRIN, Frascati (Italy), from 7 to 10 November 2022.

GEO Week 2022 (18th GEO Plenary, 59th GEO ExCom, & side meetings)

GEO Week 2022 took place in Accra, Ghana from 31st October to 4th November 2022. The theme for the week was "Global Action for Local Impact". The meeting was attended by CEOS leadership, represented by the Ivan Petiteville (SIT Chair) and the CEO, both of whom attended the GEO Executive Committee meetings and the GEO Plenary, as well as some of the side meetings and events. Additionally, an SEO team, led by Brian Killough and David Borges, ran a CEOS booth in the main exhibition hall throughout the week.

The GEO Plenary opened with a keynote address from the Vice President of Ghana, Dr Mahamudu Bawumia. In his address, he explained that a Ghanaian space policy and associated implementation plan had recently been agreed and a new "Ghana Space Agency" will hopefully be approved in 2023.

One new Member and three new Participating Organisations were welcomed into GEO this year:

- Democratic Republic of Congo
- Sociedad Futura
- Space for Climate Observatory
- West and Central African Research Network

Plenary sessions spanned the following topics:

- Operational Services for Africa. Including reporting from a 2-day side Symposium held before Plenary in the conference venue convened by AfriGEO. DE Africa was a key spotlighted success for knowledge transfer across the continent.
- Earth Observation for Nature-based solutions. Currently there is a general push to address global goals and targets on biodiversity as the RAMSAR COP in Montreal approaches in November 2022, also a lot of investment around nature-

based solutions and in ecosystem accounting. CEOS was represented by Lawrence Friedl (NASA) who presented our current proposal plans for a CEOS Ecosystem Extent Task Team.

- Road to GEO post-2025. A dedicated Working Group looking at GEO post-2025 has been set up and the group provided an interim report to Plenary. Initial considerations towards shaping the GEO Post-2025 Strategy include:
 - o Increase equitable access to Earth Observations
 - o Optimise the GEO Work Programme
 - Strengthen GEO governance
 - o Mobilise new donors, the private sector and, investigate innovative financing
 - Strengthen communications and advocacy
- Future-proofing National Adaptation Plans. There was general agreement that GEO should continue, through its Work Programme, to provide technical support for the implementation of national / regional, sector-specific early warning systems in the context of NAP processes.
- Collective Action on Oceans, Climate and Biodiversity. GEO are promoting a new direction to integrate ocean, climate and biodiversity communities. In doing so, it would be important to avoid duplicating existing efforts under existing mechanisms.
- The Way Ahead. A GEO Expert Advisory Group (EAG) has reviewed the GEOSS concept to assess if it still serves the needs of the GEO user community and to see how it can be bettered. Three options for the future of GEOSS were considered, to:
 - o Discontinue if GEOSS is to be found not to fulfil GEO's needs
 - <u>Pivot</u> where the GEOSS content is deemed valuable but that it is not being delivered within the best infrastructure
 - Enhance where existing infrastructure and partnerships were found to be adequate.

These three options would have cost saving / spending implications so the next steps in the process are to further evaluate the various options and to undertake a cost-benefit analysis.

• *Programme Board*. CEOS's membership to the GEO Programme Board (PB) has been approved for the next 3-year period (2023 – 2025).
