1. The Work Plan is now online, and it is business as usual updating the deliverables in the tracking tool.

- 2. A letter of response was sent to Johns Muleso Kharika, Chief, Science, Technology and Innovation Unit at UNCCD on behalf of the CEOS Chair on 6th June 2025.
- 3. The CEO team has been working the CEOS Chair on a Statement for COPUOS. The statement has been finalized and will be shared with the CEOS Sec prior to the meeting.
- 4. The CEO team has offered to join the CEOS Chair in meeting with GEO Secretariat Director at the ESA Living Planet Symposium. The CEO team has been supporting the SIT Chair who leads CEOS activities with GEO, including GEO Programme Board and Executive Committee meetings and other activities. Input has been provided to the talking points, but the CEO team would like to be in the meeting or have SIT Chair there.
- 5. Working Group on Capacity Building and Data Democracy
 In addition to SANSA agreeing to continue as Chair for another year, ESA has nominated
 a new Vice Chair, Christoph Aubrecht. The next in-person meeting is now confirmed in
 the margins of COPUOS in Vienna, June 2025 in meeting room M6 on 30th June/1st July.
- 6. Discussions are ongoing with various space agencies that want to participate more in CEOS. With the Hellenic Space Centre (HSC) the CEO team has assisted the drafting of the formal letter expressing interest in becoming a CEOS Member. It is currently being reviewed by the board members of HSC, and it will be shared with the CEOS Secretariat for review. The same process has been followed by the Institute of Space Studies of Catalonia who are drafting a formal letter expressing interest as a CEOS Associate Member. The Kenyan Space Agency (KSA) has also communicated with the CEO team and received the relevant guidance. Lastly, the CEO team recently met with the Norwegian Space Agency (NOSA), and the Permanent Mission of Saudi Arabia to the United Nations in Geneva who wanted to learn more about Saudi Arabia joining CEOS.
- 7. Working Group Disasters
 Pending more feedback on the approach for Early Warning for All from the CEOS Sec.
 Agenzia Spaziale Italiana (ASI) has offered to serve as Vice-Chair WG Disasters, and it is proposed that this position will be held by Antonio Montuori from ASI.
- 8. Working Group Climate
 There was a request for support from the CEO team around capacity building and
 communication for the CEOS Global Stocktake Strategy (GST) document, this has been
 shared with WG CapD.

- Working Group on Information Systems and Services
 The CEO team continues to help with input to the CEOS Interoperability Handbook.
- Working Group on Calibration and Validation
 The CEO team will provide an update/overview at the next meeting in India.
- 11. The Biodiversity Study Team
 Input has been provided to the BST Recommendation Outline and the Implementation
 Plan Outline as they prepare the results from stakeholder interviews and plan.
- 12. The CEO has now taken over the SDG Coordination Group and there are open calendar invitations for the next calls for the SDG CG members. Discussions have also taken place with the current lead of EO4SDG regarding the future of their activities. The CEO will be joint moderator with ESA on an SDG agora at Living Planet Symposium.

Proposal for CEOS Zenodo Implementation Process

Overview and Recommendation

As a collective, CEOS generates substantial documentation on Earth observation and remote sensing topics through its technical groups. This virtual library is now stored on multiple platforms, presenting challenges for discovery, consistent citation, and long-term preservation. This proposal recommends implementing Zenodo, a free digital repository operated by CERN, to establish a centralized system with automatic Digital Object Identifier (DOI) registration capabilities (https://zenodo.org/).

Zenodo automatically assigns DOI to all uploads, making documents immediately citable and trackable with enterprise-grade preservation at the CERN Data Centre. Many familiar institutions already use Zenodo to include GEO, the European Commission, Harvard University, etc. If accepted, this proposal offers a strategic opportunity to modernize CEOS document management while aligning with scientific best practices, with zero costs for upload, storage, and DOI registration. A phased approach beginning with pilot Working Groups would demonstrate value while increasing the visibility of CEOS as a leader in Earth observation coordination and scientific communication.

Value Proposition

Enhanced Discoverability: Comprehensive metadata and search capabilities improve how the Earth observation community, researchers, universities, and decision makers find and access CEOS documents through multiple discovery pathways.

Professional Citation Standards: Automatic DOI assignment establishes consistent citation practices, enhancing reach, professional presentation, and CEOS contributions in scientific literature, publications, grant applications, and other media.

Long-term Preservation: Documents are stored at the CERN Data Centre with multiple backup systems, ensuring permanent accessibility backed by institutional-grade infrastructure.

Community Collaboration: Shared workspaces enable CEOS groups to curate collections with flexible member roles and review processes tailored to different document sensitivities.

Cost-Free Implementation: Zero cost for upload, storage, and DOI registration while providing enterprise-level services and technical support.

Implementation Approach

Phase 1: SEO to establish CEOS community on Zenodo with designated administrators and metadata standards for documentation.

Phase 2: SEO to begin with a pilot Working Group (WGClimate) to test workflows, gather feedback, and demonstrate value before broader deployment.

Phase 3: SEO to initiate full community rollout with systematic migration of priority documents and integration of ongoing publication workflows.

Key considerations include training materials for users, quality assurance protocols for metadata consistency, and a governance framework defining review policies and access controls for different document types.

- WGClimate is in the process to update its Term of Reference.

New updates, particularly those that would benefit from CEOS SEC awareness, discussion, help and/or guidance

- On June 2, a teleconference was held between the CEOS SIT Chair, the CEOS Excecutive Support, the CEOS Executive Officer, Marie-Claire Greening from ESA, the WGDisasters chair and its SEC team, and Arijit Roy from ISRO (one of the coleads of EW4All subgroup). It was an interesting meeting and the following main decisions were taken.
 - The initial request set out in the 2023 letter sent by the WMO to CEOS members, which
 included a table of requirements, is no longer valid. This has been confirmed in several
 meetings held with the WMO. Therefore, there is currently no request for CEOS members.
 - It is considered best to hold a teleconference with some points of contact from the WMO and UNDRR to understand how the WG Disasters, or even CEOS members, can best collaborate with the initiative.
 - o It was agreed that the idea of the workshop should be suspended for the time being.
 - WGDisasters believes in the importance of supporting EW4All initiative. Therefore, the subgroup that has already been formed, can remain as an internal body of the WGDisasters, carrying out the activities directed by the cochairs of the subgroup and supported by the WGDisasters leads. The first step would be to understand how to collaborate with the initiative.
 - The possibility of joining either to co-chair the subgroup, or to belong to it, is open to anyone from CEOS outside of WGDisasters, and even to anyone outside of CEOS (for example: WMO, UNDRR).
- On June 5 was held the second teleconference of WGDisasters. The projects presented their progress and all the actions were review. In general, they remain open until the WGDisasters 24 meeting in September.
